PLEASE READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS

- 1. I represent and warrant to the West Side Rowing Club, Incorporated, of the City of Buffalo (WSRC) that I have full legal authority to complete this registration form on behalf of myself and/or the party that I am registering, including full authority to make use of the credit/debit card to which registration fees will be charged. If I am registering a child under the age of 18, I represent and warrant that I am the parent or legal guardian of that party and that I have the legal authority to enter into this Agreement on his/her behalf. By proceeding with this registration process, I hereby agree that the terms of this Agreement shall apply to me and/or to the registered party.
- I understand that participating in the sport of rowing can be a hazardous activity which has many dangers and risks associated with it. I understand that rowing involves risk of serious injury or even death. I agree for myself and on behalf of my heirs, assigns, personal representatives and next of kin, that as and in consideration for being permitted to row at WSRC, I freely and expressly assume and accept any and all risks, known and unknown, of injury or death to the participant and/or for property loss or damage. I assume full responsibility for personal injury to myself and (if applicable) to my family members and I further release, discharge and hold harmless WSRC for any and all injury, damage or loss arising out of my presence upon the facilities of the WSRC and/or participating in the sport of rowing, whether caused by myself, my family, by WSRC or by any third parties. I hereby release WSRC and its respective agents, directors, officers and employees from any and all responsibility or liability for injuries or damages which result, either directly or otherwise, from my participation in the sport of rowing and my presence upon the facilities of WSRC.
- 3. I agree to indemnify and defend WSRC against all claims, causes of action, damages, costs, judgments or expenses, including attorney fees and other litigation costs, which may in any way arise from my presence upon the facilities of WSRC and/or my participation in the sport of rowing. I agree to pay for all damages to the property of WSRC or any third party caused by my own negligent, reckless or willful actions.
- 4. I agree to observe and obey all rules and regulations of the WSRC and to follow any and all written or oral instructions given by the employees, coaches, representatives or agents of the WSRC. I agree and consent to WSRC using photographs or videos of me participating in WSRC sanctioned events (including training activities) for promotional purposes.
